

Solutions30 continues to diversify into renewable energies with the installation of 6 new photovoltaic plants for SEPALE

Paris, 2nd of July 2024

Following the successful launch of the Asagreen I programme, providing for the installation of photovoltaic power plants on 35 agricultural and industrial photovoltaic buildings, for a total installed capacity of 10.36 MWp, SEPALE, an expert in renewable energy, is renewing its confidence in Solutions30 by entrusting it with the Asagreen II project, involving the End-to-end installation of photovoltaic power plants on 6 new buildings.

Through this 18-month contract, Solutions30 is consolidating its diversification into the installation of photovoltaic electricity generation capacity, through integrated service in France. Solutions30 has been commissioned to carry out the remainder of this major project, with a contract covering every stage of the installation as well as project monitoring.

Keen to respond effectively to the expectations of SEPALE and all the clients in this business segment, Solutions30 has continued to develop the expertise of its teams and is working to build up an ecosystem of partners. The Group has strengthened its energy business by establishing a specialized department focused on managing Multi-site and Major Projects. This department is staffed with a dedicated team of experienced managers and technicians, further strengthened by several new hires, enabling the team to deliver turnkey end-to-end large B2B projects.

Since 2008, Solutions30 has been contributing to the construction of solar power plants on large-scale projects alongside major energy companies. The group has successfully completed more than 1.6 GW of renewable energy projects (photovoltaic and wind power), demonstrating its considerable expertise in this field. The acquisition of Elec EnR in July 2023, followed by the acquisition of a stake in So-Tec, a specialist in the construction of photovoltaic power plants, in March 2024, enables Solutions30 to expand its presence throughout France and enhance its sector expertise. By 2024, Solutions30 expects to have commissioned more than 250 MW of renewable energy projects in a year, and to have doubled its sales from this business to €50 million.
